- have made payment in full via cleared funds of the Additional Volume Target invoiced cost, and having no outstanding IOR account invoices,

you will receive a further \$200- credit note applied to your diesel purchases on your IOR Network Diesel/Bulk customer account; being **REWARD TIER 2**,

- for any approved new customers who buy >10,000 – 15,000 litres of diesel fuel (**Additional Volume Target 2**) from IOR Network Diesel sites<sup>1</sup> or via bulk purchases within 6 months of opening an account; **and**
- have made payment in full via cleared funds of the Additional Volume Target invoiced cost, and having no outstanding IOR account invoices,

you will receive a further \$200- credit note applied to your diesel purchases on your IOR Network Diesel/Bulk customer account; being **REWARD TIER 3**,
